Three Year Business Plan Update

February 2023: The Board approved the following recommendations

Accomplished:

- A committee of members to improve participation and responsiveness of Facebook and Forum platforms.
- A committee to make recommendations with regard to the Wally Smith and Keith Porter awards.
- Review and possible revision of bylaws
- Preparation of a regalia plan including a plan for any seed money required.
- Approval to investigate options altering club logo & name to de-emphasize EAST and promote the inclusion of all Rootes Vehicles
- Expansion and promotion of the BASH concept as tool for Regional Reps

Still in the works

- Procedure manual
- An expansion of TAC activities by TEAE.
- A volunteer should be sought to investigate qualifications for 501 (c)3 tax status.
- Investigate ways to expand membership west of Mississippi
- A standing committee of members to produce technical videos.

Three Year Business Plan proposed TAC improvements

- Propose we establish a TAC link on website
 - Explains the program
 - Provides info to request TAC
- Designate TAC Coordinator for club
 - Candidate would be current TAC inspector
 - Reduce current burden on Tom C and Bill B. They concur
 - Coordinator works with members/owners to schedule inspections
 - Try to be proactive...not just reactive in scheduling
 - Advertise scheduled inspections in Rootes Review

SUNI VIII (2026)

- Plan for 2026 format would be a four-day cruise of Rt 66. Change hotels everyday. No concours, autocross or hotel amenities.
 September 14-19, 2026
- Financial risks and gains shared among participating clubs same as SUNI VII
- Per existing agreements, the clubs would NOT hold a competing United in that same year.
- Board previously voted to SUPPORT IN PRINCIPLE...PENDING DETAILS
- Clubs conducted survey to gauge interest. TEAE Results:
 - 7 yes/27 probably ... yes/34 probably no ... 48 just plain no
- 2026 is the 50th Birthday of TEAE. We probably want to hold our own United that year
- Will we support SUNI VIII?

United 43 (2026)

- Need to start planning
- Possible venue: New Jersey???
 - The first organizational meeting of the TEAE Founding Fathers and Mothers took place on August 28, **1976** at Smithville, New Jersey
 - Have never held a United in New Jersey
- Other possible venues???
- Need somebody to step forward and take lead as United Chair
